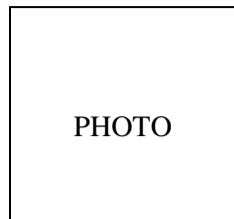

RULES & GUIDELINES OF FREEDOM EDUSOFT SUPPORT LOAN

1. The assistance under FREEDOM EDUSOFT SUPPORT LOAN interest free loan will be given only to K.V.O./Community girls
2. The loan will be given for School/College studies on the basis of merit and need base as under :
Std 3rd to 8th >>> Upto Rs 10000/-
Std 9th to Graduation >>> Upto Rs 25000/-
3. The application form has to be completed in all respect. Incomplete application, furnishing false information and hiding of any information will be liable for rejection of application.
4. Shree Bhanbai Nenshi Mahila Vidyalaya reserves the right to sanction and/or disburse the loan amount in full, part or reject the application without giving any reasons..
5. If the loan is not used for the specified purpose, Shree Bhanbai Nenshi Mahila Vidyalaya will have rights to call back the loan amount.
6. Our loans are both MERIT and NEED based. If the student is both, MERITORIOUS and NEEDY, special consideration may be granted for Loans
7. Repayment of the FREEDOM EDUSOFT SUPPORT LOAN will commence after 1 year and will have to be fully paid off within 5 years, as per the convenience of the parents, and acceptance of the institute. However, it would be mandatory for the parents to intimate the minimum amount/per month in the form.
